2021 Virtual Annual Survey Training

The training sessions were well attended with nearly 100 attendees between the two sessions. We'd like to extend our appreciation for those that were able to attend and contribute to the discussion. Summary of Survey Changes

Over the past few years, we've made a considerable number of improvements to the website, portal, survey app, manuals, and the submission process.

Some highlights of the past few years:

- Efficiencies to the registration process
 - Including primary & secondary roles
 - Allow for Health System Survey registration

> Updates to Annual and Fiscal Survey Manuals

- o Consistent look and layout for both manuals
- Removed obsolete questions
- Added appendices (list of facilities, definitions, and change log)
- > Updated Website and Timelines
 - User friendly navigation tiles
 - NEW 2021: Additional tiles added to Education & Training "How-To Submit Surveys"
 - o Combined and condensed due dates to make submissions more consistent
- Updated Survey App Tool
 - o Updates to front page of application to make it more user friendly
 - Added helpful links to quickly access manual, website, and data deliverables

- Created message center
- Updated Hospital Survey Grid icons, column headers, and added FYE
- Updated list of authorized users that hospitals are responsible for monitoring
- Submission Process Updates
 - Color-coded questions and navigation tree to correspond with type of edit
 - Each question underlined with link to previous year's Q&A and edit details
 - Rounded numbers to a flexible <u>+</u>5 to reduce hard edits
 - Auto-calculated totals
 - NEW 2021: Prefill sections III and IV to reduce validation errors
 - NEW 2021: Social Determinants of Health questions in Annual Survey
