The New NGSConnex Portal is Live


The new NGSConnex portal is live. You can't access the old NGSConnex portal anymore. Here are some things you should know:

- Access the new portal from the same NGSMedicare.com landing page and follow the on-screen prompts to migrate your account. Account migration is easy and only takes a few minutes.

 - o Initiate a Checks Search you can call the interactive voice response (IVR) system to obtain
 - o View Part B Provider Earnings to Date you can wait until the feature is available
