WIpop Data Submission Updates

In 2026 WHAIC will be rewriting and updating many of the reports that are available on WIpop and the Quarter End Processing Reports in Data Deliverables. Our goal is to produce more user-friendly and, in some cases, interactive reports via Power BI. Which is Microsoft's business intelligence tool that turns raw data from many sources like Excel, the data in the WIpop database into interactive reports.

This report will provide the necessary information to verify the collection and reporting of secondary races and the new Middle Eastern North African (MENA) race category. Ethnicity edits will be reinstated in Q126.

The collection of race data is mandated by the State of Wisconsin. This validation report displays the place of service, the number of records with a primary race and the number of records submitted with a secondary race recorded.

The purpose of this report is to help you:

- Evaluate whether secondary race data is being collected and reported consistently
- Identify opportunities to improve the accuracy and completeness of multiple race reporting.
